In view of the University Academic Calendar 2023-24, the admission schedule for intermediate semesters (3<sup>rd</sup>, 5<sup>th</sup>, 7<sup>th</sup> and 9<sup>th</sup>) in various Programs offered by the UTDs/Colleges/Institutes and MDU-CPAS, Gurugram in 2023-24 shall be as under:-

#### Note:

1. Final cut off date for admission is 30.08.2023 and, thereafter, no admission shall be made by the Department/College/Institute so as to complete the required teaching days in a semester as per University norms.
2. It shall be the responsibility of the concerned Head/Director/Principal to arrange extra classes for such students who are admitted with late fee as per above mentioned schedule.
3. The Heads/Directors/Principals of the Departments/Colleges/Institutes are requested to inform the students well in time by displaying the schedule on the notice boards etc.
4. The late fee as charged by the students in the affiliated Colleges/Institutes shall be remitted to the University alongwith the Continuation Return.
